SET-UP: Monroe County Fairgrounds, 5700 W Airport Road, Bloomington, IN Enter Gate 5 (off of Kirby Road) – Check in with the gate attendant - Set up can start at 8:00 a.m. on Friday morning and must be completed by 2:00 p.m. on Friday afternoon. If an earlier arrival or later check-in is needed, arrangements must be made in advance. At the end of the festival, you will be required to exit through Gate 5. If a change in gate is needed, you will be notified in advance. Failure to comply with these regulations can result in not receiving a camping space rental for the next year

CLEAN UP: EACH INDIVIDUAL, BUSINESS OR ORGANIZATION WILL BE RESPONSIBLE FOR THEIR OWN CLEAN UP.

QUIET HOURS: Security will be on the grounds 24 hours per day. All festival participants must abide by the Monroe County Noise Ordinance. Quiet hours are 11:00 PM until 6:00 AM during the Festival weekend. Violation of this Ordinance will result in removal from the festival grounds by the Indiana State Police.

VIOLATION OF CONTRACT: The Kiwanis Club of South Central Indiana hereby reserves the right to ask the above applicant to leave the festival in the event the applicant violates any provision of this Agreement and/or the laws of Monroe County, State of Indiana, or of the United States. The applicant will not be refunded the price paid in advance for space rental.
